

MAXIMIZE YOUR GENEROSITY WITH NAP TAX CREDITS

NextUp is an approved organization under the Neighborhood Assistance Act Tax Credit Program for Education (NAP), administered by the Virginia Department of Education. The NAP program allows individuals and businesses that make a qualified donation to receive up to a 65% credit on Virginia state taxes.

Quick Highlights:

- Tax credit up to 65% applies to the year of the donation and may be carried over for 5 succeeding years.
- Eligible gifts of \$500 - \$125,000 for individuals; \$616 for businesses with no maximum amount.
- Donations of cash, marketable securities, or retirement account distributions qualify. *Gifts from donor advised funds do not qualify for tax credits.*
- NextUp will facilitate the approval process for you to claim your Virginia tax credits.

Taxpayer at 35% federal rate who *DOES* itemize

| DONATION AMOUNT | \$1,000 | \$5,000 | \$10,000 |

| VA NAP Tax Credit (65%) | \$650 | \$3,250 | \$6,500 |
| Federal tax savings of charitable contribution – 35% of (donation minus tax credit) | \$123 | \$613 | \$1,225 |
| VA tax savings of charitable contribution – 5.75% of (donation minus tax credit) | \$20 | \$101 | \$201 |
| TOTAL TAX SAVINGS | \$793 | \$3,963 | \$7,926 |
| Net cost of contribution | \$207 | \$1,037 | \$2,074 |

Tax credits won't last...don't miss out!

NextUp has a **limited number of tax credits**. Donors who make qualified gifts are eligible for these benefits on a **first-come, first-served basis**.

Unlike a tax deduction, a **tax credit reduces a donor's tax bill dollar-for-dollar**. Examples to the left demonstrate how the NAP program can benefit taxpayers.
